# **Terms and Conditions**

This is a contract between you and Questa Kids. You must read and agree to these terms before using our services. If you do not agree with these terms, you may not register or use our services. You will be expected to follow these terms and if this is not the case, we reserve the right to terminate your account and/or subscription.

### **Registration and Responsible Adult responsibilities**
